## **Explanation of Cost and Payment Plans**

**Mission:** *The Moore Auditory Training Approach individualizes evaluations, treatment programs, and training protocols integrating the brain's auditory system with inner-ear vestibular and visual processing skills for preschoolers, students, and adults.*

### **Phone Consultation Fee: \$92.50**

- Review Moore Auditory-Visual Questionnaire Report
- Depending on MAVQ Report and location of client
  - Work and/or School Accommodation letter
  - Provide letter for audiologist when behavioral characteristics are significant
  - Collaborate with client and audiologist

### **Home or office visit: \$90.00**

- Complete TAVS test (screens auditory processing skills using calibrated equipment to assess need for a referral to an audiologist specializing in Central Auditory Processing testing)
- Complete visual processing activities to identify referral and accommodation needs

#### *Emailed to client after initial visit:*

- TAVS report (share with audiologist, ENT doctor, therapists, teachers)
- Letter to share with audiologist I recommend (will call your audiologist)
- Work and/or School Accommodation letter

Audiologist and ENT doctors bill your insurance company. Insurance companies cover the cost of hearing tests, except Uncomfortable Loudness Test. It is the client's responsibility to call the insurance company to learn if a referral is required for the Ear, Nose, and Throat doctor and a separate referral for the audiologist. You will need to be prepared to pay for the Uncomfortable Loudness Test, when requested, which is not covered by insurance.

Insurance does not cover the work completed by Moore Auditory Integration Training. All fees are the responsibility of the client or parents/guardians.

### **Auditory-Visual Training Protocol, referral and assessment support (\$320.00)**

#### *After receive test results:*

- Email written explanation of hearing test results, phone conference, educational documents
- Phone conference to discuss comprehensive visual processing/visual acuity test results
- Plan a course of action with client; email plan
- Your Auditory-Visual Training Protocol

## Billing Plans for In-Home Auditory Integration Training Program

### Payment Options:

### Pre-AIT program and Shaping program (\$120.00)

Clients with a concussion often require an intervention program before being able to successfully listen to auditory training using headphones. Clients are also often unable to listen to fifteen or thirty minutes of auditory training; thus, listening time is gradually increased until client is able to successfully listen to thirty minutes of therapeutic listening.

- Home/office visit(s) to develop program
- Follow-up phone calls, texts, and emails
- Develop a plan for a full auditory integration training program upon completion of shaping program

Cheri Moore must provide an associate ID number for client to purchase iLs equipment.

- One payment to iLs of \$2,100 or
- Monthly payment plan to iLs of \$230.00 for 10 months = total cost of \$2,300

### Auditory Training Payment Plans (\$400.00 even if client buys equipment from iLs):

#### Services Provided:

- Development of individualize listening program
- Teach how to use equipment and complete In-Home program
- Collaborate with optometrist, audiologist, and teachers
- Letter asking for school or workplace accommodations during auditory training
- Behavioral and academic support: modifications, assessments, and curriculum support
- Rental of Equipment (AIT, iLs)
- AIT - client purchases recommended CD player (available used on Ebay)

#### Payment Plans:

- A. Monthly payment of \$40.00 dollars over a period of 10 months (low income clients)
